

FAITH LUTHERAN SCHOOL
FINANCIAL COMMITMENT FORM 2010/2011

1. I/we agree to pay the tuition according to the following arrangements and to conclude all required payments before the last day of school. My/our payment preference is (Check one of the following):

_____ Payment in full by **July 26, 2010**. Families receive a 10% discount (*This applies only to families paying full tuition – NO EXCEPTIONS.*) \$200 is due per student at registration- non refundable.

_____ Payment of first semester tuition by **July 26, 2010** and second semester of tuition by **January 3, 2010**. Families receive a 5% discount – *NO EXCEPTIONS.* \$200 is due per student at registration- non refundable.

_____ Payments monthly (11- month Plan.) **First payment due on July 1, 2010**. Payments are due on the first of each month and are paid through May 2010. \$200 is due per student at registration- non refundable.

_____ Payments monthly (10- month Plan.) **First payment due on July 26, 2010**. Payments are due on the first of each month and are paid through May 2010. \$200 is due per student at registration- non refundable.

2. I/we understand that a charge of \$15.00 will be assessed on accounts not paid in full by 6:00 PM on the 10th of each month.

3. I/we understand that if we withdraw our student(s), we will be charged on the following basis:

Preschool: A two-week written notice is required, and all tuition during that two-week period is required.

K-8 School: A two-week notice is required or any pre-paid tuition will **not** be refunded.

4. I/we understand that if my/our account is 30 days (or 1 payment) delinquent the result may be the withdrawal of our student(s) from Faith Lutheran School until the account is current, or acceptable arrangements have been made with the Board of Christian Day School.

5. I/we understand that there will be a \$25.00 charge for any check returned to the school by the bank.

6. I/we agree to pay the balance of our account **before** requiring transcripts to be released.

7. In the event that our account should remain delinquent after the said time in paragraph four, and upon the discretion of Faith Lutheran Church and School, our account may be turned over to a professional agency for collection.

8. For re-enrolling students: All outstanding tuition and fees from the 2010-2011 school year must be paid in full on or before June 1, 2011 in order to continue at enrollment at Faith for the 2011-2010 school year.

9. I/we recognize that tuition and fees do not cover the total cost of a Faith Lutheran education. In light of this, I /we understand that each family is required to earn a minimum of 20 Parent Participation Points throughout the school year, if not I/we will be billed \$10 per point not fulfilled. I/we can opt out and pay a \$200 service substitution fee in lieu of earning the Parent Participation Points.

10. This document is understood to be legally binding and I/we have read and do agree to comply with the above commitment.
