1. I/we agree to pay the tuition according to the following arrangements and to conclude all required payments before the last day of school. My/our committed annual attendance (for billing purposes) for preschool is (Check one of the following for each section):

2. I/we understand that a charge of \$15.00 will be assessed on accounts not paid in full by 6:00 PM on the 15th of each month.

3. I/we understand that if we withdraw our child(ren), we will be charged on the following basis:

Preschool: A two-week written notice is required, and all tuition during that two-week period is required. Registration fees are **not** refundable.

4. I/we understand that if my/our account is 30 days (or 1 payment) delinquent the result will be the withdrawal of our student(s) from Faith Lutheran Preschool until the account is current, or acceptable arrangements have been made with the Board of Christian Day School.

5. I/we understand that there will be a \$25.00 charge for any check returned to the school by the bank.

6. In the event that our account should remain delinquent after the said time in paragraph four, and upon the discretion of Faith Lutheran Church and School, our account may be turned over to a professional agency for collection.

7. For re-enrolling students: All outstanding tuition and fees from the 2008-2009 school year must be paid in full on or before June 1, 2009 in order to continue at Faith for the 2009-2010 school year.

8. I/we recognize that tuition and fees do not cover the total cost of a Faith Lutheran education. In light of this, we will prayerfully consider what our family can do to contribute in addition to our payments.

9. This document is understood to be legally binding and we have read and do agree to comply with the above commitment.
